M/s Chistec Multifoods pvt Ltd availed OD facilities from Indian Bank, TT Nagar Branch Bhopal, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s.Chistec Multifoods pvt Ltd failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20.11.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling uponM/s.Chistec Multifoods Pvt Ltd (Borrower/ Company), Ms. Sonali Singh (Director/Guarantor), Mr. AmritamRathore (Director/Guarantor), and MrMangilalMeena (Director /Guarantor / Mortgagor),liable to the Bank to pay the amount due to the tune of Rs.95,12,680/- (Ninety Five Lakh Twelve Thousand Six Hundred Eighty rupees only)as on 19.11.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 20.11.2024.

As M/s Chistec Multifoods Pvt Ltd (Borrower/ Company), Ms. Sonali Singh (Director/Guarantor), Mr. AmritamRathore (Director/Guarantor) and MrMangilalMeena (Director /Guarantor / Mortgagor),failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 04.02.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
