Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, (it is advice please avoid last day registration) the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet well in advance or one hour before the auction end time. **(BEFORE 4.00 PM on 24.07.2026).** In case EMD amount is not available in Global EMD Wallet, system will not allow to bid.
