Villagers Build Bamboo Bridge with Own Funds in Laharighat's Joribor

The Assam Rising, Laharighat, 4 July : The residents of Joribor village in Laharighat under Morigaon district, have constructed a bamboo bridge using public donations. Without waiting for the government or administration, the people of Joribor spent their personal savings to build this bridge over the Lali Beel (lake), connecting Joribor and Dhubangkhai villages. For a

very long time, the locals have suffered immensely due to poor transport links. Despite making numerous appeals and submissions in the past, the villagers received no positive response from the authorities. The residents expressed strong anger against the late Nazrul Islam—who was a five-time MLA of Laharighat and a former cabinet

minister—as well as the current MLA minister's son, Asif Nazar. According to the villagers, an MLA whose father could not improve the transport system despite being a minister will achieve very little. Therefore, instead of relying on the MLA, the people used their hard-earned money to build the bamboo bridge. The villagers formally inaugurated the bamboo bridge by cutting a red ribbon after offering their Friday (Jumma) prayers.

Man Arrested in Cachar for Alleged Abduction of Minor Girl; Victim Rescued Safely

The Assam Rising, Silchar, July 4: A 26-year-old man has been arrested in Assam's Cachar district for allegedly abducting a minor girl, police officials said. The accused, identified as Didar Hussain, hails from Gumra Saraspur under the Katigora police station area. According to police sources, the incident came to light after the minor girl went missing a few days ago, prompting her family to raise concern. The girl's father subsequently lodged a formal complaint at Katigora Police Station, following which a case was registered and an investigation was initiated. Police officials stated that based on the complaint, a dedicated team was formed to trace the missing girl and identify the person responsible for the alleged abduction. During the course of the investigation, the police

received specific inputs regarding the possible location of the accused and the victim. Acting swiftly on the information, a police team carried out a raid at the residence of the accused on Thursday night. During the operation, the minor girl was successfully rescued without any reported physical harm. The accused, Didar Hussain, was apprehended from the spot and taken into custody for further questioning. Following his arrest, the accused was subjected to preliminary interrogation, during which police attempted to gather details about the circumstances surrounding the alleged abduction. Officials have not yet disclosed whether

the accused acted alone or if others were involved in the incident. On Friday, the accused was produced before a court in Silchar for further legal proceedings. Police have stated that the investigation is still ongoing and efforts are being made to establish all aspects of the case, including the motive behind the alleged act and the sequence of events leading up to it. Meanwhile, the rescued minor has been handed over to her family, and necessary legal and medical protocols are being followed as part of standard procedure in such cases. Police authorities have advised that strict action will be taken in accordance with the law. They have also urged the public to remain vigilant and report any suspicious activities promptly to help prevent such incidents in the future.

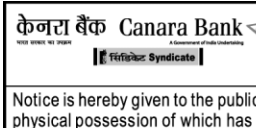
