- (1) The e-Auction is being held on "AS IS WHERE IS" and "AS IS WHAT IS" and "WHATEVER THERE IS" basis. The intending bidders should make their own discreet independent inquiries & verify the concerned Registrar/SRO/Revenue Records/other Statutory Authorities regarding the encumbrances and claims/rights/dues/charges of any authority such as Sales Tax, Excise/GST/Income Tax besides the Banks charges and shall satisfy themselves regarding the, title nature, description, extent, quality, quantity, condition, encumbrances, lien, charges, statutory dues, etc. over the property before submitting their bids. Once the KYC documents are verified by e-auction service provider(may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using mode in his Global EMD Wallet well in advance before the auction time. In case EMD amount is not available in Global EMD Wallet, system will not allow to bid. - (5) The bid price to be submitted shall be equivalent or above the Reserve Price and during the e-auction bidders will be allowed to offer higher bid in inter-se bidding over and above the last bid quoted and by minimum increase in the bid amount given in above table to the last higher bid of the bidders. The bidder shall improve their offer as specified in publication notice, which will be the bid Increase Amount. The property will not be sold below the Reserve Price set by the Authorized officer. The bid quoted below the Reserve Price shall be rejected. Unlimited extension of 10 Minutes time will be given in case of receipt of bid in last ten minutes.
