7. The interested bidders, who have submitted their EMD not below the Reserve Price before **2.00 PM on 10.07.2026**, shall be eligible for participating in the e-bidding process. The e-auction of above property would be conducted exactly on the scheduled Date & Time as mentioned against the property by way of inter-se bidding amongst the bidders. The bidder shall improve their offer in multiple of the amount mentioned under the column "Bid Increase Amount" against the property.
