

Pariyathukavu rehabilitation: foundation for houses to be laid by July 16

The plan for the houses to be built for seven Dalit families at Pariyathukavu in Malayidamthuruth near Kizhakkambalam as per a rehabilitation package announced by the government following a long-standing land dispute was handed over to the beneficiaries on Saturday.

Kunnathunad MLA V.P. Sajeendran handed over the plan, comprising three different sketches for the proposed 1,000-sq.ft. houses to the families at a meeting held at the District Collector's chamber.

The most suitable plan will be finalised by July 6, and the district commission is planning to lay the foundation for the houses by July 16, an official release said.

2.69-acre property

The houses will be built on plots of five cents each allotted to the seven families within a 2.69-acre property where they have been staying for long.

The plots were allotted to the families following government-level talks, after the landowner family won the ownership rights over the property following decades-long litigation.

The government will build the houses in the designated plots using sponsorship funds, as per the settlement agreement announced by Higher Education Minister Roji M. John on June 13.

NDPS cases, arrests double in city in a month

The numbers of cases registered and arrests made under the Narcotic Drugs and Psychotropic Substances (NDPS) Act by the Kochi City police have doubled in June compared to the previous five months, in a clear indication of increased enforcement as part of the Statewide 'Operation Toofan: The Narco Hunt'.

The city police registered 1,143 drug-related cases and arrested 1,280 people in the first six months of this year. Of these, 503 cases and 541 arrests were recorded in June alone, following the launch of the new anti-drug operation.

Among the cases registered till June this year, 27 pertained to the seizure of suspected narcotic substances in commercial quantity, 53 to intermediate quantity, and 654 to small quantity. In June alone, four cases involving commercial quantity, 21 involving intermediate quantity, and 295 involving small quantity were registered.

Sources in the police's anti-narcotic wing said the spike in cases involving intermediate quantities of

narcotic substances pointed to an alarming trend. "Most of the cases involving intermediate quantities pertain to the seizure of MDMA from youngsters. They were involved in both drug use and peddling," an officer said.

The police seized 143.71 kg of suspected ganja and 2.30 kg of suspected MDMA in the first six months of this year. Of this, 44.66 kg of ganja and 484.21 grams of MDMA—around one-third and one-fourth of the total seizures, respectively—were confiscated in June alone.

Though the impact of Operation Toofan is reflected in this year's figures, a comparison with the previous year's data shows a similar trend. The 1,143 NDPS cases registered in the first six months of 2026 account for less than half of the 3,005 cases recorded during the whole of 2025. A total of 1,280 people were arrested in connection with the cases till the end of June, compared with 3,325 arrests made in 2025.

Police sources, however, said the overall number of cases and arrests is likely to rise this year if the renewed momentum in enforcement drives continues.
