Shri Samar Roy (Borrower -Mortgagor), Address- Ground Floor, 23B, Kunja Mallick Bag Colony (Anjangerh), Dum Dum, North 24 Parganas, Kolkata 700030, availed credit facility from Indian Bank, Beadon Street Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Shri Samar Roy, failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **17.09.2022** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) **Shri Samar Roy (Borrower/ Mortgagor) , Address-Ground Floor, 23B, Kunja Mallick Bag Colony (Anjangerh), Dum Dum, North 24 Parganas, Kolkata 700030**, liable to the Bank to pay the amount due to the tune of of Rs. **15,97,346.00 (Rupees Fifteen Lakhs Ninety Seven Thousand Three Hundred Forty Six Only)** as on **17.09.2022** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 17.09.2022.

As Shri Samar Roy failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03.12.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 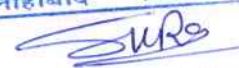

The amount due as on 10.07.2026 is of Rs. **18,19,295/- (Rupees Eighteen Lacs Ninteen Thousand Two Hundred Ninty five Only)** with further interest, costs, other charges and expenses thereon from 10.07.2026.
