M/s Agarwal Traders (Amit Kumar S/o Om Prakash Singhal) (Borrower/Mortgagor) availed OCC facility from Indian Bank, Indra Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Agarwal Traders (Amit Kumar S/o Om Prakash Singhal) (Borrower/Mortgagor) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 24.12.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), M/s Agarwal Traders (Amit Kumar S/o Om Prakash Singhal) liable to the Bank to pay the amount due to the tune of 1,24,50,256/- (**Rs. One Crore twenty four lakhs fifty thousand two hundred fifty six**) as on 24.12.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 24.12.2025.

As M/s Agarwal Traders (Prop: Amit Kumar S/o Om Prakash Singhal) (Borrower/Mortgagor) failed to make payment despite Demand Notice, the Authorized Officer took **Constructive /Symbolic/ Physical possession** of the schedule mentioned properties under the Act on 29.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.
