M/s Binita Agro Industries Pvt Ltd. availed MSME Loan facility from Indian Bank, Jehanabad Station Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Binita Agro Industries Pvt Ltd. failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 06.01.2026 under Sec. 13 (2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Binita Agro Industries Pvt Ltd., Mr Dharmendra Kumar S/o Awadh Yadav & Mr Awadh Yadav S/o Rambalak Yadav I liable to the Bank to pay the amount due to the tune of ₹ 5,17,44,033/- (Rupees Five Crore Seventeen Lakhs Forty Four Thousand and Thirty Three Only) as on 06.01.2026 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 06.01.2026.

As M/s Binita Agro Industries Pvt Ltd. failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18.03.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.
