Mr. Prasad Eknath Kharade availed **Home loan** facility from Indian Bank, Bhayandar 90 Feet Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Prasad Eknath Kharade** failed to pay the outstanding dues to the Bank. Therefore, a **Demand Notice dated 06.01.2024** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Mr. Prasad Eknath Kharade** liable to the Bank to pay the amount due to the tune of Rs.12,50,169.00(Rupees Twelve Lakhs Fifty Thousand One Hundred Sixty-Nine Only) as on **30.12.2023** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **06.01.2024**.

As **Mr. Prasad Eknath Kharade** failed to make payment despite Demand Notice, the Authorized Officer took **possession** of the schedule mentioned properties under the Act on **25.07.2024** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In

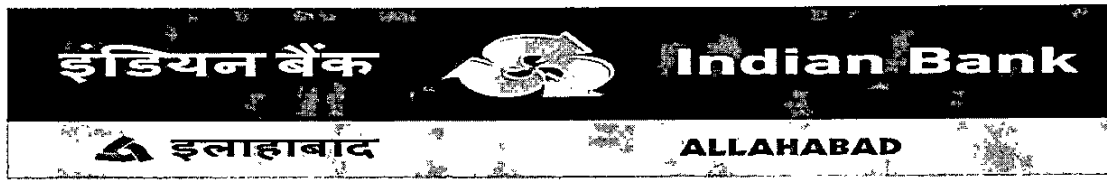
The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

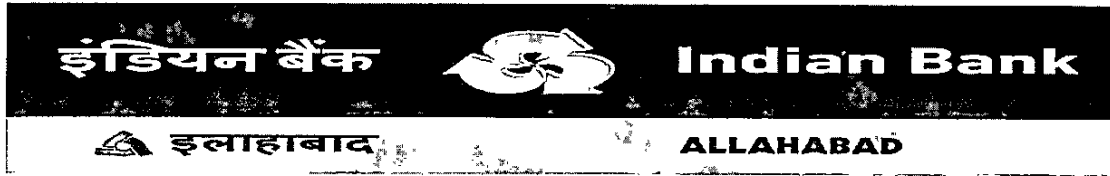

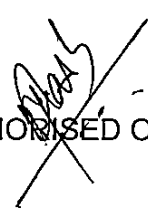
