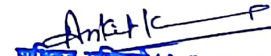

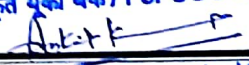


OTHER TERMS AND CONDITIONS OF E-AUCTION SALE

1. The auction sale will be "online through e-auction" portal <https://www.baanknet.com> .

Further, they are requested to upload requisite KYC documents. 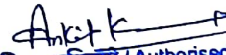
