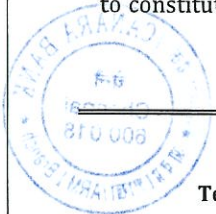

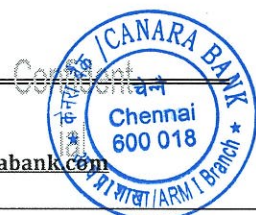

3.
