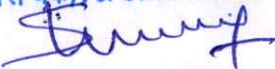

**6. Other terms and conditions:**

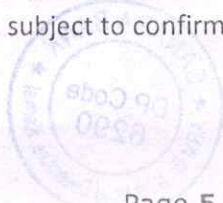
