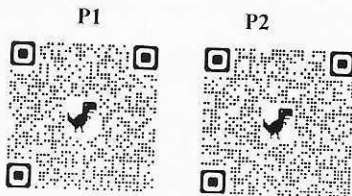

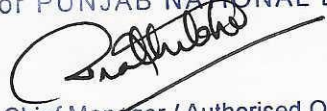
QR code of properties
