Mrs. Rajkumari (Co-Borrower/Mortgagor) and Late Manoj Kumar availed IBHL and HL Plus facility from Indian Bank, Kotwali Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. Mrs. Rajkumari (Co-Borrower/Mortgagor) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 24.06.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower(s)/Guarantor(s)/Legal Heir(s) i.e. Mrs. Rajkumari, Shakshi and Bhoomi liable to the Bank to pay the amount due to the tune of **Rs.1707997/- (Seventeen Lakh Seven Thousand Nine Hundred And Ninety Seven Only)** as on 24.06.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 24.06.2025.

As Mrs. Rajkumari, Shakshi and Bhoomi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.09.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 06.07.2026 is **Rs. 20,15,676/- (Rupees Twenty lakhs fifteen thousand six hundred & seventy-six Only)** with further interest, costs, other charges and expenses thereon from 07.07.2026.
