Notice of sale under Rule 8(6) read with 9(1) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Sub: Loan account – Mrs. Sitara Bano (A/c No Term Loan-50387843845 with Indian Bank, Kurla

Mrs Sitara_Bano availed Term loan facility from Indian Bank, Kurla the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Sitara_Bano failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 11.05.2017 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) Mrs Sitara Bano and Mr. Vishal Ahmad liable to the Bank to pay the amount due to the tune of Rs. **22,70,400.00** (Twenty lakh Seventy Thousand Four hundred only.) as per demand notice dated 11.05.2017 with total amount of 2498456.00 (Rupees Twenty-four lakh ninty eight thousand four hundred fifty-six Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 11.05.2017.

As Mrs Sitara Bano and Mr. Vishal Ahmad failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION
ADOPTING THE e-AUCTION MODE.**

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 14.07.2026 is Rs 25,27,577/- (Rupees Twenty-Five lakhs Twenty Seven Thousand five hundred seventy-seven Only) with further interest, costs, other charges and expenses thereon from 14.07.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 31.07.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **27.07.2026** to **30.07.2026** between **10.00 am to 5.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The terms and conditions of e-auction is available in the website (<https://baanknet.com>).

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **30.07.2026** i.e the e-Auction Date and before the e-auction end time in the portal. The registration and eKYC must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website <https://baanknet.com> (PSB Alliance Pvt. Ltd.) **for depositing in bidders EMD Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and

If the e-auction fails owing to any technical snag etc., the same may be re-scheduled by issuing 7 days' prior notice.

This Notice is without prejudice to any other remedy available to the Secured Creditor and without prejudice to rights of the Secured Creditor to proceed with the proceedings presently pending before DRT/RO of DRT/ DRAT/ Court and proceed with the execution of order/decreed obtained/to be obtained.
