Sri Priya Tech, Prop- Mrs. Gayathri availed **1- OCC under IND SME Secure & 2- SME Secure Term Loan machinery under AABCS** scheme facility from Indian Bank, Panruti Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s. Sri Priya Tech, Prop- Mrs. Gayathri** failed to pay the outstanding dues to the Bank. liable to the Bank to pay the amount due to the tune of **Rs. 25,35,370/- (Rupees Twenty Five Lakhs Thirty Five Thousand Three Hundred and Seventy Only)** as on **08.10.2025** with further interest, costs, other charges and expenses thereon from **09.10.2025** . Both failed to make payment despite Demand Notice dated **08.10.2025**.

As **M/s. Sri Priya Tech, Prop- Mrs. Gayathri** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **18.12.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **13.07.2026** is **Rs. 26,85,733/- (Rupees Twenty Six Lakhs Eighty Five Thousand Seven Hundred and Thirty Three Only)** with further interest, costs, other charges and expenses thereon from **14.07.2026**.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 30.07.2026 from 11.00 am to 4.00 pm which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **14.07.2026 to 30.07.2026** between **10.00 am to 4.00 pm**.
