M/s Baidyanath Enterprise availed ...OCC facility from Indian Bank, Burdwan nutanganj Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s... Baidyanath Enterprise failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 05.09.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s)...**as mentioned above** from sl no 1 to 8 liable to the Bank to pay the amount due to the tune of **Rs.8251715/- (Rupees Eighty two lakhs fifty one thousand seven hundred and fifteen Only)** as on 05.09.2025. with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 05.09.2025 .

As M/s Baidyanath Enterprise.. failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21.11.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
