

Major Development in ‘Prasna’ Ravan Case: Bank Accounts Frozen

Hyderabad :

The Andhra Pradesh police have intensified their ongoing investigation into Bachalakuri Joseph, alias ‘Prasna’ Ravan, the founder and administrator of the controversial ‘Prasna’ website and YouTube channel.

In a strategic move to choke his financial operations, the Kakinada police have frozen his active bank accounts held with ICICI Bank and Yes Bank. Official communications were dispatched to the respective banking authorities, resulting in the immediate suspension of all fi-

nancial transactions linked to his name. The YouTuber was previously arrested following a wave of complaints regarding highly provocative and inflammatory speeches directed at Deputy Chief Minister Pawan Kalyan and other public figures holding constitutional offices.

The legal situation escalated significantly after the Ganavaram police invoked the stringent Unlawful Activi-

ties Prevention Act against him for allegedly promoting banned extremist ideologies through his digital content.
