M/s Adinath Rice Mill availed credit facilities from Indian Bank, (erstwhile Allahabad Bank), Satgachia Branch, the repayment of which are secured by mortgage of schedule mentioned properties, hereinafter referred to as 'The Properties'.

M/s Adinath Rice Mill failed to pay the outstanding to the Bank. Therefore, a demand Notice dt. **30.07.2025** under Section 13(2) of the Securitization & Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as 'The Act') was issued by the Authorized Officer, calling upon **M/s Adinath Rice Mill** and others liable to the Bank to pay the amount due to the tune of Rs. **51374921.00**

(Rupees: Five Crore Thirteen Lakh Seventy-Four Thousand Nine Hundred Twenty-One Only) as on **30.07.2025** with interest, cost, other charges and expenses thereon. Both failed to make payment despite, demand notice dated **30.07.2025**

M/s Adinath Rice Mill and others failed to make payment despite the above demand notice, the **Authorized Officer** took possession of the scheduled mentioned properties under the Act on **10.10.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, the Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards the outstanding balance. In accordance with the same, the authorized officer intends selling the schedule mentioned securities in the following mode.

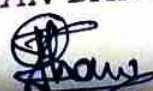
The Authorised Officer/Bank has the absolute right to accept or reject any bid or adjourn /postone /cancel the sale without assigning any reason therefor.

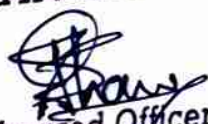
