Barkha w/o Aroonesh Bharti availed Loans from Indian Bank, **Panchali Khurd Branch**, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Barkha w/o Aroonesh Bharti** failed to pay the outstanding dues to the Bank.
