M/s Alok Mitra, S/o- Late Ganesh Mitra availed HBL-1, HBL-2, Ind Kavach from **Indian Bank, Ghuskara Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Alok Mitra (borrower & mortgagor) , Mr Subhash Chandra Saha and Mrs Hira Mitra (guarantor)** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **20.08.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / mortgagor / guarantor **Alok Mitra (borrower & mortgagor) , Mr Subhash Chandra Saha and Mrs Hira Mitra (guarantor)**, liable to the Bank to pay the amount due to the tune of **₹ 5,92,687/- (Rupees Five Lakh Ninety Two Thousand Six Hundred & Eighty seven Only) as on 20.08.2025** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 20.08.2025.

As **Alok Mitra (borrower & mortgagor) , Mr Subhash Chandra Saha and Mrs Hira Mitra (guarantor)** failed to make payment despite Demand Notice, the



Authorized Officer took possession of the schedule mentioned properties under the Act on **12-11-2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The date of sale is fixed as 27th of July, 2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
