Ms. Ankita D/o Mr. Ashok Kumar Mishra availed a Term & working capital Loan from Indian Bank, Dadinpurwa Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Liabe to the Bank to pay the amount due to the tune Rs. 3225476/- (Rupees Thirty Two Lakh Twenty Five Thousand Four Hundred and Seventy Six Only) as on 18.03.2026 with further interest, costs, other charges and expenses thereon. Ms. Ankita, Mrs. Kiran Mishra(Mortgagor & Guarantor) & Mr. Ashok Kumar Mishra(Guarantor) failed to make payment despite Demand Notice dated 20.03.2026.

As Ms. Ankita D/o Mr. Ashok Kumar Mishra failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 23.06.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. *As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 12.07.2026 is Rs. 3298491/- (Rupees Thirty Two Lakh Ninty Eight Thousand Four Hundred and Ninty One Only) with further interest, costs, other charges and expenses thereon from 13.07.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.
