Notice dated **05.03.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Sri Ram Enterprises liable to the Bank to pay the amount due to the tune of **Rs.32,03,382/- (Rupees Thirty Two Lakhs Three Thousand Three Hundred and Eighty Two Only)** as on **05.03.2026** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **05.03.2026**.

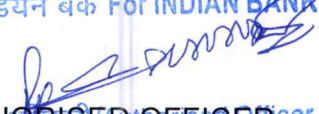
