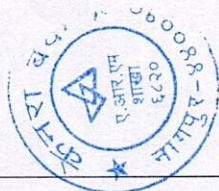

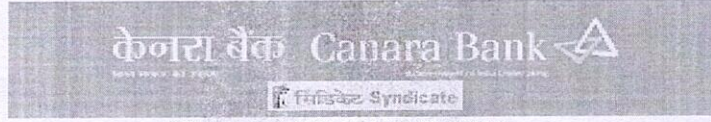

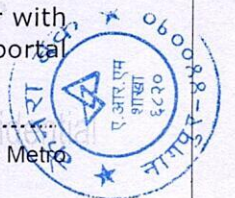

e.
