E-Auction Sale Notice

Whereas the borrower having failed to pay the amount dues in full to the bank as called for in the said demand notice, the bank has taken possession of the secured assets more fully described in the schedule hereunder on 04.12.2025 under Section 13(4) of the Act with the right to sell the same in "As is where is" and "As is what is" basis under section 13(4) of the Act read with the rules 8&9 of the Security Interest (Enforcement) rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as **Rs. 48,92,574/- (Rupees Forty Eight Lakhs Ninety Two Thousand Five Hundred Seventy Four Only)**, payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to deposit the EMD amount in SARFAESI Sale Parking Account No.10380113035001 by **11.08.2026 before 01:00 P.M for Security 1 and 23.07.2026 before 01:00 P.M for Security 2**.
