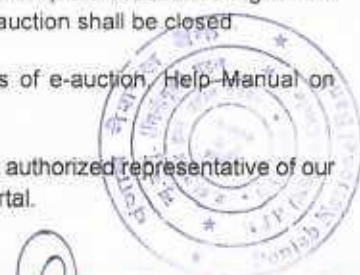

7. Bidder's e-Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.

8.
