

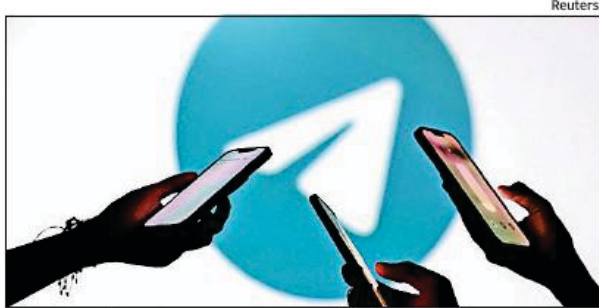
Curb pirated content or face action, govt warns Telegram

Issues Notice To Firm, Seeks Action Taken Report Within 15 Days

New Delhi: The Centre has served a notice to popular messaging app Telegram, directing it to crack down on the "widespread dissemination" of pirated films, OTT content and other audio-visual material through its platform, govt officials said Saturday.

In its notice, the Ministry of Information and Broadcasting sought an action taken report from Telegram within 15 days, with officials underlining that govt's approach marks a shift from piecemeal takedowns of pirated content to "platform accountability".

The ministry is learnt to have told Telegram, which was temporarily blocked in India in June as a precautionary measure to prevent any

paper leak during the NEET re-examination, that copyright infringement is not merely a civil violation, but also a criminal offence under the Copyright Act, 1957, and the Cinematograph Act, 1952.

"The Ministry has made it clear that Telegram cannot

merely wait for the government to identify each piracy channel one by one. A purely reactive, channel-by-channel takedown approach may not be enough to demonstrate due diligence by the platform, as required under the IT Act, 2000, and the IT Rules,

2021," officials said.

The notice to Telegram follows the Centre's recent regulatory action against Meta. On Wednesday, the Ministry of Electronics and Information Technology (MeitY) issued a notice to Meta questioning the planned username feature on WhatsApp and, later in the week, decided to summon the company over Instagram ads allegedly promoting child sexual abuse material.

Telegram and another messaging app Signal have also been served notices by MeitY on their existing username feature. Meanwhile, I&B Ministry has also sought details of Telegram's grievance redressal mechanism for producers, OTT platforms and law enforcement agencies, sources said.

Investment pact with Israel takes effect

New Delhi: The India-Israel Bilateral Investment Agreement (BIA), which will ensure a secure and predictable investment climate between the two countries, came into force from Saturday, the finance ministry said.

The pact, which will provide protection to the two-way investments, is expected to contribute to increased cross-border investment activity it said.

The two countries inked the treaty on September 8 last year. "The BIA between the Government of the Republic of India and the Government of the State of Israel enters into force with effect from today, 04 July 2026," the ministry said.

Under the pact, India has cut down the local remedies exhaustion period for Israeli investors to three years.

The agreement is expected to pave the way for increased bilateral investments between the two countries. The government has earlier announced revamping the current model of BITs.

Closeted and exhausted? How safe, affirmative spaces can help

To help readers cope with their anxieties in these stressful times, TOI's Talk it Out series brings expert counsellors to answer your mental health queries. This week's advice is from clinical psychologist Arpita Misra

■ **Being a queer person in a conservative environment in Delhi has left me depressed. I have known myself to be a transwoman since I was seven. I am 26 now, but have never been able to come out to anyone besides a therapist, who somehow thought it to be a fetish. This was after I told her that I want to be a woman while being attracted to women. I am still closeted and pretending to be a man for the house, but I hate every moment of my life.**

It's clear that you've been carrying this on your own for a very long time. What also comes through is that you haven't felt safe enough to express who you truly are. Living this way can be emotionally exhausting. Please remember, your gender identity and sexual orientation are both valid aspects of who you are. It must have taken a lot of courage to share this in therapy, only to feel that your experience was dismissed. I hope this doesn't stop you from giving therapy another chance. When you feel ready, a queer-affirmative therapist can offer the safe, respectful, and affirming space that therapy is meant to be. It can also help ease the sadness, loneliness, and emotional exhaustion you've been living with for so long. Coming out is a deeply personal decision, and your emotional and physical safety should always guide that decision. While you may not be able to change your circumstances immediately, look for small, safe ways to express your identity through writing, music, creative hobbies, or by connecting with LGBTQIA+ affirming support groups or communities. Finding people who truly understand and accept you can remind you that you don't have to face this alone.

■ **My mother shames me for reaching a breaking point but ignores my boundaries daily, dismisses my feelings and criticises me over and over again. She repeatedly puts me in uncomfortable situations with help from siblings, neighbours and even maids, passing on all my personal information to my younger siblings and her own sisters. She has ensured that no one talks to me. My brother and his wife spend most of their time in my space, and my mother has enabled that. My father is no more and she wants me to vacate his house, but I don't have the means to do so. What do I do?**

Living with ongoing criticism, repeated boundary violations, a lack of privacy, and feeling emotionally unsupported can take a significant toll on



anyone. You're also carrying the uncertainty of your living situation and the loss of your father, which can make everything feel even heavier. Reaching a breaking point is often our mind and body's way of telling us that the stress has become too much to carry alone. Your reaction deserves understanding, not shame. Creating small routines that are just for you, spending time outside the house, going for a walk, staying connected with trusted friends, or engaging in activities that make you feel calm and grounded can help you regain a sense of control. You could consider speaking with one of your siblings about this, and what kind of support you need from them. They may not fully realise the impact this has had on you, but even one supportive conversation can make a difference. Over time, therapy can help you process these experiences, strengthen healthy bounda-

ries, recognise your own strengths, and support you in finding practical ways of moving forward.

■ **I'm a 41-year-old divorcee staying with very old parents. I was laid off three months ago, the third time in three years. I don't have any friends and my CV gets rejected most of the time. My communication skills are not that great. I was never a very career-oriented person but right now, need a job to survive. My loneliness is also an issue. I feel there's no point of me being alive, but I think I would be a coward to end my life. My peers in school and college are all well settled. I am the only one who didn't reach anywhere. My parents sent me to a good school but I was always an average student. What kind of job can I look for? Is there any training offered free of cost for personality development? Please help.**

You have been carrying a great deal, and it's understandable that finding a way forward feels difficult right now. What stayed with me most was your feeling that there is no point in being alive. No setback, rejection, or disappointment can determine the value of your life. The way you're feeling right now deserves care, support, and attention. The pressure to find a job can feel overwhelming. Start by updating your CV using online CV review tools or professional guidance, widening your search to include part-time roles, and continuing to apply consistently to improve chances. Communication skills can be developed with practice through free online courses, mock interviews, or communication workshops. Your years of work experience reflect skills and strengths. Although the current job market is challenging, avoid measuring your progress against your peers as everyone's path is different. Loneliness often makes emotional distress feel even heavier. Try to gradually create opportunities to connect with others through a hobby, volunteering, a community group, or simply spending more time outside the house. Building even a small support system can make difficult times feel a little more manageable. A counsellor or psychologist can help you process feelings of hopelessness, rebuild confidence, show your strengths, build communication skills, and work with you to identify practical ways of moving forward. The fact that you are asking for help tells me that a part of you still hopes things can change. Hold on to that, and take one small step at a time.
