Govt plans bill to punish those who insult, block Vande singing

Delimitation, Women's Quota Bills Not On Agenda Yet

New Delhi: A bill providing for punishment for any insult or obstruction to singing of Vande Mataram will be introduced in Lok Sabha in Parliament's session starting July 20. The Prevention of Insults to National Honour (Amendment) Bill, cleared by the Union Cabinet earlier, comes after guidelines issued by the home ministry made playing or singing the national song mandatory at official events where national anthem 'Jana Gana Mana' is played.

Bills listed for introduction in LS include one making the delayed registration of birth and death stringent.

Once the prevention of insults to national honour bill is cleared by both LS and RS, the law will make insulting the national song a punishable offence, bringing it

among the other high symbols of the republic, like the national anthem; the national flag; and the Constitution, whose insult attracts criminal action.

BJP has maintained that past 'secular' govts did not accord Vande Mataram, interwoven with the freedom movement, its due place as they related to objections from a section of Muslims due to the song's Hindu imagery. There have recently been instances where Vande was allegedly not given due respect by state govts belonging to opposition parties or

net's clearance, with govt sources saying its timing will be firmed up once the session begins.

Registration of Births and Deaths (Amendment) Bill, cleared by Cabinet Tuesday, proposes births and deaths reported after two years can be registered only on the order of a first-class judicial magistrate, replacing the existing provision under which approval from a DM, SDM or executive magistrate sufficed.

Supreme Court (Number of Judges) Amendment Bill will stamp Parliament's nod to the ordinance which has increased the strength of judges in SC from 33 to 37.

The contentious Foreign Contribution (Regulation) Amendment Bill, which was introduced in LS in the last session and drew sharp criticism from opposition for its alleged targeting of funding of NGOs, especially those linked to Christian bodies, and the Viksit Bharat Shiksha Adhishthan Bill, which seeks to overhaul higher education regulation and is being scrutinised by a parliamentary panel, are among other bills for LS's consideration and passing.

Fema civil law, allows compounding of offences, reiterates ED

New Delhi: ED Thursday reiterated Fema is primarily a civil legislation that through Section 15 provides for compounding of contraventions to facilitate voluntary compliance, reduce litigation and ensure expeditious disposal of cases, except those involving serious crimes like money laundering, terror financing and affecting country's sovereignty and integrity.

"In all cases, RBI is the competent authority to compound eligible contraventions," the agency said.

The role of ED, which is the designated agency to investigate all violations of Foreign Exchange Management Act (Fema) after recommendation from RBI, is to issue a no-objection certificate to the central bank with regards to compounding of offences. The clarification came as RBI ordered closure of another Fema case by allowing compounding of offences against Apothecan Pharmaceuticals.

"RBI has also issued master directions on compounding of contraventions under Fema, prescribing a compounding matrix for determining the compounding amount based on factors such as the nature, gravity, duration and amount involved in the contravention," ED said.

It said once RBI compounds the contraventions, ED

drops proceedings and closes the investigation. "Major cases where it has closed the investigations are brought to the notice of public at large through press releases so that in the case of similar pending investigations, application for compounding may be filed by the offenders before the RBI," it added.

In the latest case against Apothecan Pharmaceuticals, compounding of offences has been allowed after the accused paid a penalty of Rs 40 lakh for offences which included delay in reporting foreign inward remittances, issue of shares before receipt of remittances and issue of equities without approval of govt.

"As a policy, ED issues an NOC where the contravention is eligible for compounding, the prescribed conditions are fulfilled and no investigation or other legal impediment exists. This facilitates voluntary compliance, reduces avoidable litigation and promotes ease of doing business," ED said.

NSA urges decisive action by BIMSTEC to deal with geopolitical uncertainties

New Delhi: NSA Ajit Doval chaired the 5th Meeting of BIMSTEC national security chiefs as the grouping that bridges South Asia and Southeast Asia discussed "practical and result-oriented" solutions to combat terrorism and organised crime, ensure security in the cyber, maritime and energy domains, enhance connectivity and tackle new and emerging threats.

The security chiefs also endorsed a set of guiding principles on the conduct of maritime law enforcement agencies during interactions at sea.

These principles are expected to outline reference points for increasing predictability and promoting safety during



maritime engagements among member states, said India in a statement.

Doval stressed the need for closer regional cooperation to tackle evolving security challenges, saying the current global landscape marked by conflicts, geopolitical uncertainties and technological disruptions requires BIMSTEC member states to work together and take "decisive action" for their mutual benefit.

New Delhi: Army chief General Dhiraj Seth, who is on a visit to the Eastern Command, reviewed the operational preparedness of the Tezpur-based IV Corps, also known as the Gajraj Corps, on Thursday. In two days, he visited the headquarters of the XXXIII Corps or Trishakti Corps, in Sukna and the III Corps (Spear Corps) in Dimapur.
On Wednesday, the Army chief went to Bengdubi military station, which holds immense strategic value as it stands at the northern entrance of the crucial Siliguri Corridor (also referred to as 'Chicken's Neck'). The vital strip of land separates Nepal from Bangladesh and is less than 20 km wide at its narrowest section. As the only road and rail link connecting the rest of India to the northeast, this corridor is of critical importance to national security.
