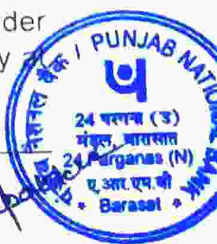
#### TERMS AND CONDITIONS OF E-AUCTION SALE

The auction sale will be "online through e-auction" portal <https://baanknet.com>

Once the e-KYC is done, the intending Bidders/ Purchasers may transfer the EMD amount to their e-Wallet using online/challan mode before the e-Auction Date and time in the portal. The
