

Rs 500-crore 'fake silver offerings' at Vaishno: Court summons probe officer

A COURT in Jammu has asked an inquiry officer of the J&K Police's Crime Branch to appear personally before it with records pertaining to alleged offerings of "fake silver" worth around Rs 500 crore at the Shri Mata Vaishno Devi Shrine in the Trikuta Hills near Katra.

The directions from Chief Judicial Magistrate, Jammu, Munish Kumar Manhas, came on Monday in an application filed by Advocate Deepak Sharma. The CJM has listed the matter for July 29.

Sharma had earlier submitted a detailed complaint before the Inspector General of Police, Crime Branch, Jammu, and the Senior Superintendent of Police, Crime Branch, Economic Offences Wing, Jammu, seeking registration of an FIR and a comprehensive investigation into the alleged "adulteration, substitution and possible misappropriation" of silver offerings at Shri Mata Vaishno Devi Ji Shrine. The complaint dated May 9 had alleged cognizable offences like criminal conspiracy, cheating, criminal breach of trust, misappropriation, manipulation of records and the possible procurement or use of cadmium-laden material.

The complainant said that

he approached the court seeking an action taken report and a direction for the registration of an FIR and investigation, claiming that no effective action was disclosed by the Crime Branch.

The Crime Branch had filed a status report pursuant to the court's directions, stating that the complaint had initially been forwarded to the Crime Headquarters, Srinagar, for approval and, after receipt of such approval, it was thereafter forwarded to the Zonal Police Headquarters, Jammu, for "appropriate action".

Advocate Sharma, on Monday, argued that the mere administrative forwarding of the complaint does not amount to lawful action upon information disclosing cognizable offences.

He submitted the Crime Branch, Economic Offences Wing, is notified police station, with its Superintendent of Police functioning as the Station House Officer. He also pointed out that the status report did not disclose any steps having been taken for the preservation of crucial evidence. The controversies arose from reports that 20 tonnes of silver offerings made at the shrine, stated to be worth Rs 500 crore, were sent by the Shrine Board for testing, melting and processing, and that only 5-6% of the material was found to be actual silver.

Staines murder: Convict Dara seeks release

THE SUPREME COURT on Tuesday directed the Odisha government to decide within a month on the remission plea of Ravindra Pal alias Dara Singh, who is serving a life sentence for the 1999 murder of Australian missionary Graham Staines and his two minor sons.

A Bench of Justices Manoj Misra and Vijay Bhishnoi adjourned the matter to August 19 after the Odisha government informed the court that the State

Sentence Review Board, which is examining Singh's plea, had sought certain records that were yet to be made available.

"In such circumstances, we deem it appropriate to adjourn this matter to 19/08/2026. In the meantime, we expect that the committee shall take its decision," the Bench said.

Speaking to *The Indian Express*, Singh's counsel A P Singh said the state informed the court that the State Sentence Review Board had considered 56 remission cases, including Singh's, at its July 6 meeting.

"The state sought more time to verify certain records as Singh belongs to Auraiya district in Uttar Pradesh. The court has asked it to take a decision by August 15," he said. A senior govt. official said the state was awaiting records from the Auraiya district authorities.

Singh has been lodged in Keonjhar district jail for 26 years. He moved SC in July 2024 seeking remission, stating he had spent 14 years in prison and had repented for his actions. He was 37 when he was arrested.
