प्रॉपर्टी डीलर दफतर पर चली गोलियाँ गैंगस्टर गोल्डी ढिल्लों ने ली जिम्मेदारी

नकाबपोशों ने करीब 8 राउंड किए फायर, इलाके में दहशत

राजपुरा। राजपुरा-पाटियाला सड़क पर स्थित लक्की प्रॉपर्टी डीलर के दफतर में शुक्रवार को दिनदहाड़े फायरिंग हुई। दो अज्ञात नकाबपोश युवकों ने लगभग 8 राउंड फायर किए, जिससे इलाके में दहशत फैल गई। हालाँकि, इस घटना में कोई जानी नुकसान नहीं हुआ और दफतर का स्टाफ सुरक्षित है।

वारदात की जिम्मेदारी गैंगस्टर गोल्डी ढिल्लों ने ली है। थाना सिटी राजपुरा के एचएचओ गुरसेवक सिंह पुलिस बल के साथ मौके पर पहुंचे। पुलिस सीसीटीवी फुटेज खंगाल रही है और डीवीआर कजे में ले लिया गया है। प्रत्यक्षदर्शियों के अनुसार हमलावर एकट्ठा पर आए थे। एक युवक बाहर खड़ा रहा जबकि दूसरा अंदर दाखिल हुआ। उसने महिला कर्मचारी से मालिक रमेश पट्टना के बारे में पूछा। मालिक के न होने पर हमलावर ने रिस्टलों से अंधाधुंध गोलियाँ चलाई और फारा हो गया। गुरसेवक सिंह ने बताया कि एक ही युवक सीसीटीवी में दिख रहा है। पुलिस मामले को भीगीरता से जांच कर रही है और जल्द गिरफ्तारी का आश्वासन दिया है।

पाँश इलाके में वारदात: लक्की प्रॉपर्टी डीलर के मालिक रमेश पट्टना राजपुरा के नामी प्रॉपर्टी डीलर हैं। वह विधायक नीना भिस्तल के भी करीबी माने जाते हैं। उनका दफतर जजी की रिहाइश और मिनी सेक्टरस्ट्रीट के पास है। यह इलाका सुबह से शाम तक काफी चहल-पहेल वाला रहता है। इतने पाँश इलाके में ऐसी वारदात होना पुलिस के लिए चुनौती है। पुलिस इस मामले में सभी सीसीटीवी फुटेज खंगाल रही है।
