

# Cannot remain silent about officiating in Egypt’s 3-2 loss to Argentina: EFA

The Egyptian Football Association (EFA) said Wednesday it “cannot remain silent” after what it believes was unfair and biased officiating in Egypt’s 3-2 round of 16 loss against Argentina.

Egypt coach Hossam Hassan and several players criticised the officiating after being left in disbelief as Argentina scored three unanswered goals in 13 minutes to pull off one of the biggest comebacks in World Cup history.

“Defending the rights and interests of the Egyptian national team is not a matter that can be ignored, minimised, or treated as secondary,” the EFA said in a statement. “It is a responsibility that we carry with full conviction and determination.”

FIFA’s chief of refereeing Pierluigi Collina, in a statement issued later Wednesday, said while constructive discussion about decisions would always be part of football, “unfounded



allegations have no place in our sport.”

“Nobody can question the integrity of the FIFA World Cup match officials,” he said. “When this happens, it may provoke reactions that lead to threats against them and their families. This is not right.” The EFA said that the referee failed to use the Video Assistant Referee (VAR) system appropriately, leading to the loss to Argentina.

Egypt appeared to have netted its second goal in the 58th minute, but a VAR review determined that Marwan Attia had fouled Argentina defender Lisandro Martinez early in the buildup up to the goal. “Several key incidents raised serious concerns and left profound questions about the consistency and fairness of decisions that directly influenced the course of the game,” the EFA statement read.

Collina said “during a competition, we prefer not to focus on specific incidents,” but he defended the Attia decision. “If a foul is identified in the

build-up and is deemed to have had an impact on the goal, the VAR will recommend an on-field review,” Collina said. “There is no defined limit regarding either the distance from goal or the amount of time between the incident and the goal.” He said in the disputed case, Attia

“clearly treads on the foot of Argentina No. 6 Lisandro Martinez.” “We believe that a foul is a foul,” Collina added.

“Regardless of whether the foul appears obvious,’ if the referee did not see it on the field of play, the VAR can intervene.” (AP)

## Belgium gets serious for quarterfinal with Spain

No more playful dances. No more taunting social media posts. Belgium is done celebrating its victory over the host United States and hard at work on extending its World Cup run on American soil.

The Red Devils trained in the Los Angeles area on Wednesday with the memory still fresh of their 4-1 thrashing of the Americans in Seattle on Monday. After surviving a test from Senegal with a thrilling comeback and then thoroughly dominating the US in its first two knockout games, Belgium faces its toughest challenge yet against unbeaten Spain in the quarterfinals on Friday. But this tumultuous World Cup run has sparked something in this Belgian team, goalkeeper Thibaut Courtois believes.

“We gained a lot of confidence, because we knew it was going to be a hard game against America,” Courtois said at the LA Galaxy’s suburban stadium. “They’re obviously the home team with a full stadium (that’s) with them, so it’s nice to perform in a good way defensive, offensively, and just play our game.”

Belgium went into the US matchup with a world of indignant motivation after star American forward Folarin Balogun’s one-game red-card suspension was curiously lifted by FIFA. The Red Devils took it out on an outclassed American team and then celebrated gleefully, both on the pitch and in the dressing room. In the most viral moment, many players did the simplistic dance associated with US President Donald Trump and performed by numerous athletes across the sports world in recent months, including American star Christian Pulisic.

Belgium left back Diego Moreira smiled slightly when asked about the meaning of doing the dance after Trump called FIFA President Gianni Infantino to ask for a review of Balogun’s red card. “There are different ways to celebrate different goals,” Moreira said through an interpreter. “You can do different dances, and that’s what we’ve done. We just celebrated the win after the game.” Courtois said he wasn’t in the dressing room because he was at doping control, so he couldn’t comment on the dance. The Red Devils say they’ve put that cathartic evening behind them after landing for their second game of the tournament to be played at SoFi Stadium in the Los Angeles area. (AP)

## Henderson returns to England camp after surgery

England midfielder Jordan Henderson rejoined The Three Lions at their World Cup training base after undergoing surgery on his left wrist following a freak injury that he sustained while celebrating their Round of 16 triumph over Mexico last weekend. The 36-year-old Henderson posted a photo on social media of his left arm wrapped after the procedure at the Kansas City Orthopaedic Institute, which is about a 10-minute drive from their team hotel in the suburb of Prairie Village, Kansas. “Surgery done!” Henderson said. “Now let’s get ready for the big one Saturday.” Henderson, who has been ruled out for the remainder of the World Cup, had been an unused substitute for Sunday’s match against Mexico at Azteca Stadium in Mexico City. The Three Lions had just survived a 3-2 thriller to advance to a quarterfinal against Norway when Henderson hurt his wrist while climbing over an advertising billboard.

Henderson was taken from the field on a stretcher and remained in Mexico City while the rest of England’s players returned to their base camp in Kansas City, Missouri.
