Sub: Your IND SME Mortgage 6838138988 with Indian Bank Villupuram Branch.

Mrs. Anis Fathima availed **IND SME Mortgage** facility from Indian Bank, Villupuram Branch. The repayment of loan is secured by Mortgage of schedule mentioned properties. **Mrs Anis Fathima** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.10.2023 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s) and Guarantor(s), liable to the Bank to pay the amount dues to the tune of **Rs 98,11,662/- (Rupees Ninety Eight Lakhs Eleven Thousand Six Hundred and Sixty Two Only)** as on **21.10.2023** and the said amount carries further interest at the agreed rate, Charges, expenses from 21.10.2023 till date of repayment. You have failed to make payment despite Demand Notice dated 21.10.2023.

As **Mrs. Anis Fathima** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 31.01.2024 after complying with all legal formalities. The physical possession of the scheduled mentioned property was taken by the Authorized officer under the Act on 25.06.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends to sell the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER / AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) and 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and



Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **08.07.2026** is **Rs. 1, 37, 35,536 /-** (Rupees One Crore Thirty Seven Lakhs Thirty Five Thousand Five hundred and thirty six only) with further interest, costs, other charges and expenses thereon from **09.07.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed on 27.07.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc may be done by the intending purchasers/bidders at their expenses **from 09.07.2026 to 26.07.2026 from 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason thereof.
