Mrs. Sufi Khatoon W/o **Tamanna Khan** and **Mr. Tamanna Khan** S/o **Lt Muzibur Rahaman** has availed Home Loan facility from Indian Bank, **Bokaro Western Avenue** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties, hereinafter referred to as "the Properties". **Mrs. Sufi Khatoon and Mr. Tamanna Khan** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **08/04/2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s), mortgagors liable to the Bank to pay the amount due to the tune of **₹ 21,78,562/- (Rupees Twenty one Lakhs seventy eight thousand five hundred sixty two Only)** as on **08/04/2026** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **08/04/2026**.

As **Mrs. Sufi Khatoon** and **Mr. Tamanna Khan** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **22/06/2026** after complying with all legal formalities.

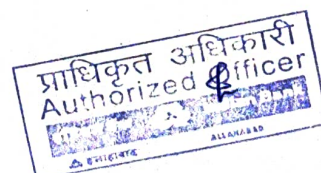
As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, **30 day's** notice for sale is required to be given and hence we are issuing this notice.

The amount due as on **08/04/2026** is **Rs. ₹ 21,78,562/- (Rupees Twenty one Lakhs seventy eight thousand five hundred sixty two Only)** with further interest, costs, other charges and expenses thereon from **08/04/2026**.

The date of sale is fixed as 27/08/2026 which would be by e-auction mode.
