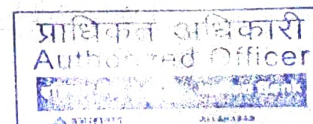
M/s Kumar EV Motors Prop. Kumar Saurav and Mr. Sanjay Sharma have availed Loan facility under OCC INDSME SEC-MICRO SMAL-REPO and PMEGP-TERM LOAN-REPO scheme respectively from Indian Bank, Bokaro Western Avenue Branch, the repayment of which is secured by Mortgage of schedule mentioned properties, hereinafter referred to as "the Properties". M/s M/s Kumar EV Motors Prop. Kumar Saurav and Mr. Sanjay Sharma have failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 15/07/2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s), mortgagors liable to the Bank to pay the amount due to the tune of ₹ 44,97,317/- (Rupees Forty Four Lakhs Ninety Seven Thousand Three Hundred Seventeen Only) as on 15/07/2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 15/07/2025.

As M/s Kumar EV Motors Prop. Kumar Saurav and Mr. Sanjay Sharma failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 25/09/2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 day's notice for sale is required to be given and hence we are issuing this notice.

The amount due as on 15/07/2025 is Rs. ₹ 44,97,317/- (Rupees Forty Four Lakhs Ninety Seven Thousand Three Hundred Seventeen Only) with further interest, costs, other charges and expenses thereon from 15/07/2025.
