The bidder who submits the highest bid on closure of e-Auction process shall be declared as Successful Bidder and communication to that effect will be issued which shall be subject to approval by the Authorized Officer/Secured Creditor.

h. Sale shall be confirmed in favour of the successful bidder, subject to confirmation of the same by the secured creditor.

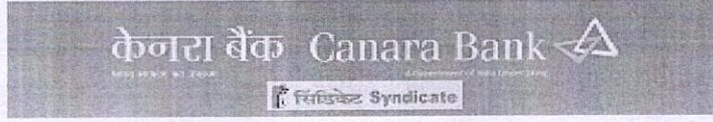
i.
