Wangchuk vows to survive till July 20 as hunger strike hits day 20

NEW DELHI: Climate activist and educator Sonam Wangchuk on Friday said he would continue his indefinite hunger strike until July 20, despite doctors warning that his health condition had reached a critical stage. His fast entered its 20th day as the Cockroach Janta Party (CJP) protest at Jantar Mantar completed 28 days.

Addressing supporters at the protest site, Wangchuk acknowledged that his physical strength had weakened but said his determination remained firm. He appealed to people to participate in the proposed peaceful march to Parliament on July 20, stating that the protestors would present their demands before the “temple of

democracy.” Doctors monitoring Wangchuk’s condition warned that continuing the prolonged fast could lead to serious health complications, including possible organ damage. However, Wangchuk refused to end his hunger strike, saying that withdrawing without any government response would send the wrong message.

PURI: The annual Rath Yatra festival of Lord Jagannath, Lord Balabhadra, and Devi Subhadra in Odisha’s Puri witnessed immense devotion and participation from lakhs of devotees despite rain and humid weather conditions. The ceremonial chariot procession, which began on Thursday, continued on Friday as devotees pulled the three grand chariots towards the Gundicha Temple, located about 2.6 kilometres from the 12th-century Shree Jagannath Temple.

Due to a delay in the ‘Pahandi’ rituals on Thursday, the three chariots could not reach their destination and remained stationed on the Grand Road overnight. On Friday morning, devotees gathered in large numbers and pulled the chariots amid chants of “Jai Jagannath,” with the atmosphere filled with devotional songs, cymbals, trumpets, and conch shell sounds.

Gajapati Maharaja Dibyasingha Deb, regarded as the chief servitor of Lord Jagannath and the sibling deities, clarified through a video message that there was no religious issue with pulling the chariots on the following day. He explained that on several occasions in the past, chariots had not reached the Gundicha Temple on the scheduled day and the journey continued the next morning. He added that the pulling
