

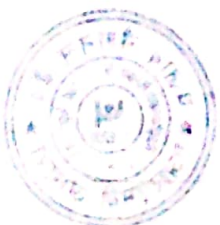

TERMS AND CONDITIONS OF E-AUCTION SALE

- The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions.
(1) The auction sale will be "online through e-auction" portal <https://baanknet.com>
The intending Bidders/ Purchasers are requested to register on portal (<https://baanknet.com>) using their mobile number and email-id. Further, they are requested to upload requisite eKYC documents. Once the eKYC documents are verified by e-auction service provider, the intending Bidders/ Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet. The registration, verification of eKYC documents and transfer of EMD in wallet must be completed well in advance.
- Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through various modes i.e. NEFT/ RTGS in bidders Global EMD Wallet. NEFT/RTGS transfer can be done from any Scheduled Commercial Bank, Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction.
