'33L filed appeals against EC decision to delete name'

Appearing for the petitioner, senior advocate Gopal Sankaranarayanan said that as many as 33 lakh people have filed appeals against the EC decision to delete their names from the voter list. Appellate tribunals have so far disposed of 30,000 appeals of which 70% were allowed, which means their names have to be included in the voter list, he said.

However, he said the BJP govt was quating the EC decision to delete people's names from the voter list as final adjudication of citizenship and depriving them of receiving benefits under welfare schemes - foodgrain under the public distribution system and the Annapurna Yojana. The bench said speedy adjudication of appeals must be chiefed before the Calcutta HC could be justified. However, it entertained the plea on other issues.

NEET top score goes up to 715 against 686 last yr

But only 19.99 lakh candidates appeared, down from 22.09 lakh — a decline of nearly 2.1 lakh. Attendance consequently dropped from 97.1% to 87.7%.

The number qualifying fell from 12.37 lakh to 11.21 lakh, a decline of 9.3%. Yet the success rate among those who appeared remained virtually unchanged at about 56.1%, showing that the fall in qualifiers was largely an absentee story rather than a collapse in performance. Under the category-wise qualifying criteria, UR and EWS candidates must secure at least the 50th percentile, while OBC, SC and ST candidates require the 40th percentile. For candidates with benchmark disabilities, the qualifying requirement is the 45th percentile for UR/EWS and the 40th percentile for OBC, SC and ST.

In marks, the 2026 ranges were 715-213 for UR/EWS, 212-177 for OBC, SC and ST, 212-194 for UR/EWS-PwBD and 193-177 for most reserved-category PwBD candidates. The ST-PwBD range was 191-177.

The NTA table shows 9.97 lakh clearing at the UR/EWS threshold, while 8,111 OBC, 29,947 SC and 12,452 ST candidates qualified within the lower score band.

Separately, the category-wise results show that 61.8% of EWS candidates, the highest rate, followed by 60.7% of OBC candidates. The qualification rate was 52.4% among SC candidates, 51.2% among General and 49% among ST. In absolute terms, 5.12 lakh of the 8.43 lakh OBC candidates who appeared qualified, compared with 2.91 lakh of 5.89 lakh General, 1.59 lakh of 3.04 lakh SC candidates, 95,026 of 1.54 lakh EWS candidates and 63,716 of 1.30 lakh ST candidates. The top score also recovered sharply to 715, against 686 in 2025, though it remained below the perfect 720 recorded in 2024. "Candidates got a longer runway to the re-exam, and those who returned were arguably the more committed lot. The distribution has clearly moved up, but the data by itself cannot apportion how much of the rise came from better preparation and how much from a leaner pool," a senior NTA official said.
