9 dead, 6 injured in Ahmedabad firecracker factory blast

Ahmedabad, July 18

AT LEAST nine persons were killed and six injured in a blast and fire in an illegal firecracker unit in Ramol area of Ahmedabad on Saturday. Officials said that the toll may rise due to the critical condition of some of those hospitalised with burns. According to primary reports, about 15 people were inside the premises at the time of the blast and subsequent fire

that took place around 3:30 pm. Officials said that personnel at the camp of the Rapid Action Force (RAF) of Central Reserve Police Force (CRPF) rushed to the spot after the explosion and began rescue operations before the fire brigade teams arrived. “The RAF personnel provided immediate assistance, and local police along with the AMC’s fire teams reached the site and brought the fire under control,” Sector-2 Additional Commissioner of Police Jaypal Singh Rathore said. According to the Ahmedabad Municipal Corporation

(AMC), the fire has been brought under control and cooling work is being carried out at the spot to prevent further flare-ups. The bodies, and injured persons were dispatched to two hospitals in the city in ambulances. Dr Rakesh Joshi, Superintendent of Ahmedabad Civil Hospital, said that a person was brought dead and five injured were under treatment. Sources reported that at least one of the injured died. At LG Hospital in Maninagar, four persons were brought dead, and five injured are undergoing treatment, said Superintendent Dr Leena Dabhi. “Of the five

under treatment, three are children and they are in critical condition, one adult male is also critical, and one female is out of danger,” said Dr Dabhi. Rathore, said, “...A person named Mehul Dodiya was operating an illegal firecracker factory in an open field near a canal. The factory’s licence had already been cancelled, but the factory was operational.” The Ramol police will register a case for culpable homicide not amounting to murder and under sections of the Explosives Act. The FSL teams and other agencies have been summoned to the site.
