Sub: Home Loan (NRI) of Mr. Prethish Jose (A/c No. 7065153815) for Rs. 30.00 Lakh with Indian Bank, Aluva Metro Station Branch- Reg.

Mr. Prethish Jose availed the above loan facilities from Indian Bank, Aluva Metro Station Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Prethish Jose failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 27.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) Mr. Prethish Jose, Guarantor(s) Mrs. Jency Prethish liable to the Bank to pay the amount due to the tune of **Rs.28,38,596/- (Rupees Twenty Eight Lakhs Thirty Eight Thousand Five Hundred and Ninety Six only)** on 26.04.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 27.04.2026.

As Mr. Prethish Jose failed to make payment despite Demand Notice dated 27.04.2026, the Authorized Officer took possession of the schedule mentioned properties on 15.07.2026 under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:



THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **20.07.2026** is **Rs. 29,10,244.00 (Rupees Twenty-Nine Lakhs Ten Thousand Two Hundred Forty-Four Only)** with further interest, costs, other charges and expenses thereon from **21.07.2026**.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 31.08.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
