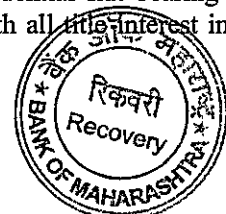

1. Nature and Object of Online Sale:

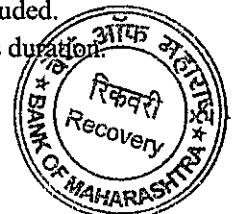

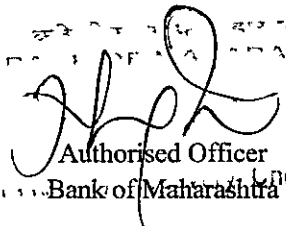
