M/s. Sri Sabari Traders, Represented by its Proprietor : Mr. R Sabari availed loan facilities from Indian Bank, Neelankarai Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s. Sri Sabari Traders, Represented by its Proprietor : Mr. R Sabari failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 18.06.2025 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling M/s. Sri Sabari Traders, Represented by its Proprietor : Mr. R Sabari and another liable to the Bank to pay the total amount due to the tune of Rs. Rs. 4314208/- (Rupees Forty three lakhs Fourteen thousand Two hundred and eight only) with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 18.06.2025.

As M/s. Sri Sabari Traders, Represented by its Proprietor : Mr. R Sabari failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 29.09.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The total amount due as on 20.07.2026 is Rs.52,08,052/- (Rupees Fifty Two Lakhs Eight Thousand And Fifty Two Only) with further interest, costs, other charges and expenses thereon from 21.07.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 10.08.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

The intending Bidders/Purchasers are requested to register with online portal (<https://www.baanknet.com>) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://www.baanknet.com>) **for depositing in bidders e-Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. If the e-auction fails owing to any technical snag etc., the same may be re-scheduled by issuing 7 days prior notice.

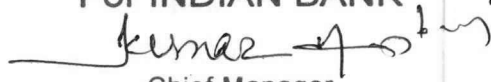
