Mr Rajeev Kumar availed 1. Home Loan facility from Indian Bank, Greater Noida Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties" Mr Rajeev Kumar failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 06.11.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mr Rajeev Kumar S/o Mr Deshraj Singh and Mrs Neelam Tomer w/o Mr Rajeev Kumar (Co-Borrower) liable to the Bank to pay the amount due to the tune of Rs. 16,07,000/- (Rupees Sixteen lakh Seven Thousands Only) as on 06.11.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 06.11.2025.

As Mr Rajeev Kumar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.02.2026 after complying with all legal formalities.

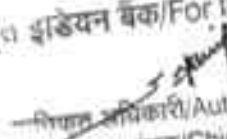
As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 06.07.2026 is Rs. 17,44,345/- (Rupees Seventeen Lakh Forty Four Thousand Three Hundred Forty Five Only) with further interest, costs, other charges and expenses thereon from 06.07.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/ Authorized Officer any time after 30 days.
