Mr. M. Annadurai and Mrs. S. Vijayalakshmi availed loan facilities from Indian Bank, Royapettah Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. M. Annadurai and Mrs. S. Vijayalakshmi failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 13.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Mr. M. Annadurai and Mrs. S. Vijayalakshmi liable to the Bank to pay the total amount due to the tune of Rs.17,03,479.57 (Rupees Seventeen lakhs three thousand four hundred seventy nine and paise fifty seven only) with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 13.04.2026.

As Mr. M. Annadurai and Mrs. S. Vijayalakshmi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 03.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

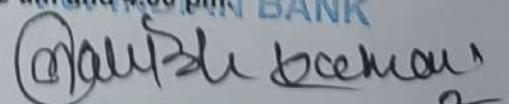
As per Rule 6(2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The total amount due as on 07.07.2026 is Rs.17,24,198/- (Rupees Seventeen lakhs twenty four thousand one hundred and ninety eight only) with further interest, costs, other charges and expenses thereon from 08.07.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 12.08.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

The intending Bidders/Purchasers are requested to register with online portal (<https://www.baanknet.com>) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.

If the e-auction fails owing to any technical snag etc., the same may be re-scheduled by issuing 7 days prior notice.

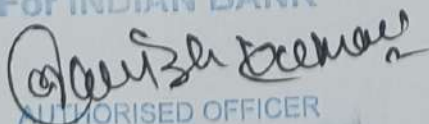

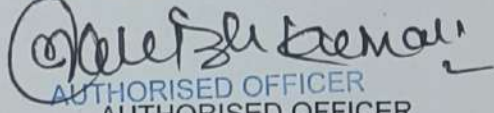
