Miss Swapnali P Kambli & Smt Sucheta P Kambli availed HL facility from Indian Bank, Kandivali East Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Miss Swapnali P Kambli & Smt Sucheta P Kambli failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 31.01.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Miss Swapnali P Kambli & Smt Sucheta P Kambli liable to the Bank to pay the amount due to the tune of Rs 18,51,881.00 (Rupees Eighteen Lakhs Fifty One Thousand Eight Hundred Eighty One Only) as on 31.01.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 31.01.2023



Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website <https://baanknet.com> (PSB Alliance Pvt. Ltd.) **for depositing in bidders EMD Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
