M/S Nandeibam Traders (Proprietorship Firm) availed Cash Credit and Term Loan facility from Indian Bank, Imphal Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. M/S Nandeibam Traders failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 12.02.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) 1. M/S Nandeibam Traders (Sole Proprietorship Firm) 2. Mr. Uttam Kumar Nandeibam (Proprietor cum Mortgagor) S/O Nandeibam Ibohanbi Singh 3. Mr. Nandeibam Ibohanbi Singh (Guarantor) S/o Nandeibam Nodiachand Singh 4. Mr. Sadokpam Kedernath Singh (Guarantor & Mortgagor), S/o Sadokpam Modhuchandra Singh liable to the Bank to pay the amount due to the tune of **Rs. 1,96,68,526.00 (Rupees One Crore Ninety Six Lakh Sixty Eight Thousand Five Hundred and Twenty Six only)** as on **11.02.2025** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 12.02.2025.

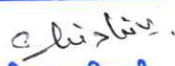
As M/S Nandeibam Traders failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **15.05.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **11.02.2025** is **Rs. 1,96,68,526.00 (Rupees One Crore Ninety Six Lakh Sixty Eight Thousand Five Hundred and Twenty Six only)** with further interest, costs, other charges and expenses thereon from 12.02.2025.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 10.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **01.08.2026 to 09.08.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/ Purchasers have to transfer the EMD amount in his Global EMD Wallet by **09.08.2026** i.e before the e-Auction Date and time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.

NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefor.
