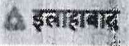

Pankaj Padmakar Kalamkar represented by legal heirs viz **Kalpna Padmakar Kalamkar (Mother of the deceased Named Pankaj Kalamkar)** AND OTHERS availed Home loan facility from Indian Bank, Satara Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. Shri. Pankaj Padmakar Kalamkar represented by legal heirs viz **Kalpna Padmakar Kalamkar (Mother of the deceased Named Pankaj Kalamkar)** AND OTHERS (**Borrower/Mortgagor**) failed to pay the outstanding dues to the Bank. As Shri. Pankaj Padmakar Kalamkar represented by legal heirs viz **Kalpna Padmakar Kalamkar (Mother of the deceased Named Pankaj Kalamkar)** AND OTHERS and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18.02.2025(Symbolic) and physical possession taken on **19.06.2026** after complying with all legal formalities.
