NOTICE OF SALE

Notice of sale under Rule 9(1) of The Security Interest (Enforcement) Rules 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mr. V.J. Pushpa Kumar had availed credit facility from Indian Bank, Esplanade Branch, the repayment of which is secured by mortgage of schedule mentioned property hereinafter referred to as "the Properties". **Mr. V.J. Pushpa Kumar** had failed to pay the outstanding, therefore a Demand Notice dated **28.06.2021** under Sec 13 (2) of Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorised Officer calling **Mr. V.J. Pushpa Kumar and another** liable to the Bank to pay the amount due to the tune of **Rs.73,85,369.04 (Rupees Seventy Three lakhs Eighty Five Thousand Three hundred and Sixty Nine and paise four only)** with further interest, cost and other charges and expenses thereon. Both failed to make payment despite Notice dated **28.06.2021**.

As **Mr. V.J. Pushpa Kumar** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned property under the Act on **18.11.2021** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **15.07.2026** is **Rs.1,08,79,388/- (Rupees One crore eight lakhs seventy nine thousand three hundred and eighty eight only)** with further interest, costs, other charges and expenses thereon from 16.07.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 07.08.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **30.07.2026 to 31.07.2026 between 10.00 am and 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

Further, after completing their eKYC, the intending Bidders/Purchasers have to transfer the EMD amount in their e-Wallet before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://www.baanknet.com>) for depositing in bidders e-Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefor.
